



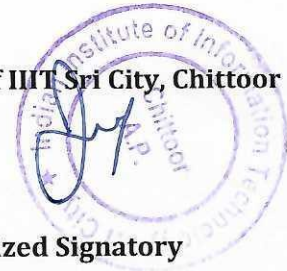

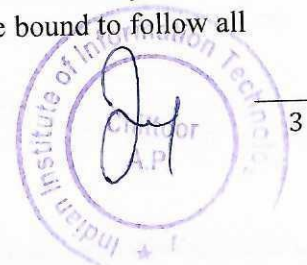

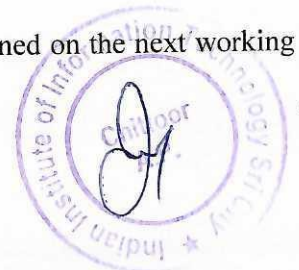
11. The quotation should be submitted strictly in the prescribed 'Annexure A' and should remain valid for a minimum of Three (3) months.
- The bidder should have experience of having successfully completed similar works
 - Documentary evidences for work experience, GST, PAN all as indicated & required in the NIQ document should be furnished

16. The successful bidder has to ensure the safety of the manpower/vehicles deployed in the premises. IIIT Sri City will not be responsible for any incident arising during execution of the work.
17. Water for works shall be provided by IIIT.
18. Accommodation and Transportation should be arranged by contractor themselves.

- 100% of Bill Value for the works shall be made after completion of work within 30 days with applicable tax deductions.

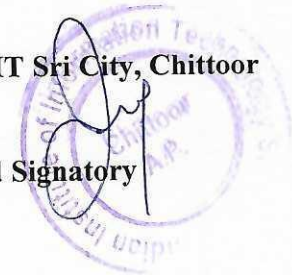
