IIIT Sri City Reporting Process UG Admissions (B.Tech) through JoSAA/CSAB 2024 (For Online document verification between 10th August, 2024 and 14th August, 2024 & IIIT Sri City balance Fee payment through SB Collect only (There is no fee waiver for any category at IIIT Sri City Chittoor)

Dear candidate,

We congratulate you for securing admission to BTech programme in IIIT Sri City through JoSAA/CSAB special rounds. All candidates who have confirmed their seats through JoSAA-2024 and/or CSAB-2024 Special Rounds I & II are required to complete the admission process as per JoSAA/CSAB guidelines/instructions. Candidates are also required to pay the balance Fee, failing which their allotment may be canceled and no refund will be admissible. Therefore, the balance fee has to be paid to IIIT Sri City and upload the documents through google form. The uploaded documents will be verified by the allotted institute (IIIT Sri City) from 10th August, 2024 (10:00 Hrs) to 14th August, 2024 (17:00 Hrs).

Steps to be followed to towards the admission process:

- Fee payment related: Candidates who have paid the partial admission fee/Institute
 Admission Fee -II to JoSSA/CSAB and received the provisional admission letter from
 JoSAA/CSAB 2024 are required to pay the balance Fee Rs.173,600 (Gen, Gen-EWS,
 OBC-NCL) OR Rs.216,100 (SC, ST, PwD) to IIIT Sri City through SB Collect (details are
 given in the Annexure A)
- 2. After the completion of remaining balance fee payment to IIIT Sri City, you need to upload the required documents (list of documents is provided in Appendix B) for verification using the following link: https://forms.gle/vg1sVitwDw3Zpz5aA
- 3. The documents uploaded by the candidates will be **verified by IIIT Sri City** during 10 Aug 2024 (Sat) (10:00 hrs) to 14 Aug 2024 (Tue) (17:00 hrs), also the admission confirmation letter from IIIT Sri City will be sent on a first come first serve basis.

- 5) All payments will be accepted only online through SBI Collect and no other means/modes of payment will be accepted.
- 6) The students must pay the fees for semesters 2 to 8 at the beginning of each semester as per the approved fee structure notified on the Institute website.

- (ii) ST certificates from Tamil Nadu state must be issued by the concerned Revenue Divisional Officer.
