### Item No. BoG10/RP3:

To take on record the Presentation of the Director's Report

Director's Report: As Director (Addl Charge), undertook the responsibility and maintaining the rich culture, and heritage of this institute. Important academic events that happened since took over the responsibility of Director (Addl Charge) are given below:

(a) <u>Completion of new admissions for UG-1</u>: 425 students have taken admission including 7 DASA students. B Tech AI & DS has been introduced this year with 60 vacancies and addl 10% supernumerary has been fully subscribed.

(b) <u>Karyashala (Workshop) on Geospatial intelligence and applications (SERB sponsored)</u>: The SERB-sponsored high-end workshop on Geospatial intelligence and applications held for six days from 26 - 31 July 2023. This Karyashala explored the intersection of two emerging fields, namely, machine learning and geospatial technologies. Early career scientists should understand the fundamentals and prospects of both domains to strive for research and technology for societal development. The course covered the basics and advancements of geospatial intelligence along with its prospective applications. The Karyashala brought together well-known experts in various domains from prominent institutes such as IISc Bangalore, IIT

Bombay, IIT Roorkee, IIST, ISRO, IARI, Indian Army, etc. Participants included Scholars, Students along with industry professionals from across the country. The participants were able to appreciate the use of machine learning in solving open problems in the geospatial technology domain. The workshop had around 30 participants and all shared a very good feedback. This workshop was inaugurated by the Director and Prof BK Mohan from IIT Bombay had given the inaugural address.

(c) <u>Workshop on Computer Vision Driven UAV Applications in Precision Agriculture</u>: Our team of faculty members, is engaged in a sponsored project funded by the TiHAN - IIT Hyderabad under the National Mission on Interdisciplinary Cyber-Physical Systems (NMICPS) Scheme of DST Govt. of India. Institute organized a two-day workshop on "**Computer Vision Driven UAV Applications in Precision Agriculture**" from 08-09 Sep 2023, to benefit the researchers, scientists and students who are working in the field of precision agriculture using IoT, UAV based solutions for real world problems in agriculture. The purpose of this workshop is to discuss the technical challenges and present state of project outcomes in leveraging the UAV and AI technologies. The workshop broadly covered areas of, Application of computer vision models in Precision Agriculture, Cyber Physical Systems modeling of Autonomous UAV based data acquisition systems, Challenges and solutions in Autonomous UAV based data acquisition systems, Discussion on application of UAV frameworks in Precision Agriculture and example case studies. Keynote Talk is given on "Eyes in the Sky: Unveiling the Future of UAV Applications with Computer Vision" by Prof. Vineeth Balasubramaninan - IIT HYD.
