#### TENDER FORM

- 1. Bid Documents: The interested parties may collect the bid documents from the Office of the Registrar or download them from the IIIT Sri City website https://www.iiits.ac.in/tenders/
- 2. Bidders are advised to visit the website frequently to find any addendum/Corrigendum issued or extension of due date for submission, etc. No separate intimation will be issued /Advertised in this regard.
- 3. The tender in TWO bid systems in sealed envelopes in single cover consisting of TWO inner sealed covers (containing Technical bid and Price bid) super scribing the NIT No., Name of the work, Bidder name & address addressed to the Registrar, IIIT Sri City, Chittoor, 630, Gnan Marg, Sri City, Tirupati District, AP, PIN:517 646. Tenders can be dropped in the tender box kept in the Office of Registrar at Academic Block of IIIT Sri City Permanent Campus only. The tender bids received after due date and time will not be accepted and considered. The tenders will be opened by the Tender opening Committee to decide the technical suitability of their service based on the pre-laid terms and conditions on the same day at 11:10 hrs at the Office of Registrar in the presence of tenderers, who wish to be present, either by themselves or through their authorized representatives (1 per agency allowed to present during the opening of bids with the authorization letter & ID Proof).
- 4. Interested parties are advised to inspect the site first and work out the requirements between 10:00 AM to 05:00 PM on any working day from 17.2.2025 to 19.02.2025. The Institute will not be responsible for deviation in the quotes submitted, without inspecting the site.
- 5. No other mode of submission is acceptable.
- 6. Offer must be legible, clear and free from overwriting and cutting. Incomplete submissions are liable to be rejected.
- 7. Validity: Minimum validity of the quotation must be 60 days from the date of opening of the quotation/tenders.
- 8. If the date of opening of the bid is declared as holiday, it will be opened on the next working day at the same time.
- 9. The overall lowest bidder will be considered for award of purchase order.
- 10. Bids to be submitted in this tender form and all pages must be duly signed by the bidder failing which bid may not be considered.
- 11. Tender shall be submitted in official tender form only. Submission in other format will be summarily rejected. Each and every page has to be signed & numbered and no paper shall be detached from the tender.
- 12. The name and address of the tenderer shall be clearly written in the space provided and no overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender should be filled in and submitted in strict accordance with the instruction laid down herein: otherwise the tender is liable to be rejected.
- 13. The tender is liable to be rejected if complete information is not given therein, or if the particulars and data (if any) asked for in the schedules to the tender are not filled in.

- 14. Tenderer should have the experience of organising at least THREE similar functions of National Level Institutes/Govt. Organizations/ / Corporate Commercial/ Non Commercial Events/ Celebrity Events/ Product Launch Shows/ Movie Promotion etc. Proof of experience such as copy of work order / agreement etc. to be attached with the tender.
- 15. The firm must be registered with GST and other statutory authorities and to enclose the copies of the relevant certificates along with the bid.
- 16. The schedule of items/services required is as per Part B Annexure 'A' (Price Bid) of this tender form and the evaluation of bid will be on the basis of total bid value. Institute reserves the right to change the quantity or cancel the item/service required.
- 17. The rates quoted should be on FIRM & FIXED basis. The Prevailing duties/taxes must be clearly mentioned by the agencies/tenderers, wherever applicable. In case the same is not mentioned clearly, then the quoted rates will be considered as inclusive of all and no additional payment will be applicable towards taxes/ duties etc.
- 18. IIIT Sri City Chittoor reserves the right to accept or reject any or all the offer either fully or partly without assigning any reasons and is not bound to accept the lowest bid since due weightage shall be given to several factors besides the financial quote.
- 19. The Work Order shall be awarded by the Institute based on the quotes with requisite documents. The awarded agency to provide their services as per the schedule and requirements projected by the institute in the tender/work order/subsequent discussions with the committees.
- 20. The firm / contractor should deploy sufficient number of technically and professionally qualified personnel for the event. They have to depute technically qualified executives, who can coordinate the event as per the directions of team and can take immediate decisions on behalf of the firm. The name, designation and contact number of the coordinator should also be provided in the tender. The staff deployed should have proper uniform and should wear the firms identity card.
- 21. The venue with all the installations (like carpeting, Chairs, speakers, mic, lightings etc.) should be ready on or before 08.00 PM on 27.02.2025, failing which penalty will be imposed as decided by the Competent Authority. All the required furniture and fittings are to be brought to the site latest by 2.00 pm on 26.2.2025. The firm has to arrange for loading/unloading of the items by deploying their own staff/ authorized labourers of the locality and Institute in no way will be responsible for the same. No excuse in delays in bringing the required materials/completing the work as sought will be entertained.
- 22. The firm / contractor must ensure that the materials being used are of standard quality, dimensions & other parameters and to be quoted accordingly. In case items / services are not as quoted the same shall not be accepted. No payment, claims for such items shall be entertained.
- 23. The contractor has to ensure that the premises are kept clean before and after the event. The collection and disposal of garbage from the venue generated during the function has to be carried out by the firm at their risk.
- 24. IIIT Sri City shall in no way be responsible for any default with regard to any statutory obligation from the side of Vendor/Contractor and will indemnify IIIT Sri City in case of any damage or liability, which may arise on account of action of any reason.
