Dear candidate,

We congratulate you for securing admission to BTech programme in IIIT Sri City through JoSAA/CSAB counseling. All candidates who have confirmed their seats through JoSAA-2025 and/or CSAB-2025 Special Rounds I, II & III as per the JoSAA/CSAB guidelines given in CSAB website are required to complete the following process for the academic year 2025-2026 at the allotted institute (IIIT Sri City) from 20<sup>th</sup> August, 2025 (10:00 Hrs) to 23<sup>rd</sup> August, 2025 (17:00 Hrs) by paying balance fee and uploading the documents through google link at the allotted Institute (IIIT Sri City). The link will be activated from 13th August, 2025 till 5pm on 23<sup>rd</sup> August, 2025. It is **compulsory** to **complete** the process to **confirm admission in IIIT Sri City**.

### A. Steps to be followed to towards the admission process:

- Fee payment related: Candidates who have paid the partial admission fee to JoSSA/CSAB and received the provisional admission letter from JoSAA/CSAB 2025 are required to pay the balance Fee Rs.1,91,000 (Gen, Gen-EWS, OBC-NCL) OR Rs.231,000 (SC, ST, PwD) to IIIT Sri City through Canara Easy Fee portal (details are given in the Annexure A)
- 2. After the completion of remaining balance fee payment to IIIT Sri City, you need to upload the required documents (list of documents is provided in Appendix B) for verification using the following google link.. The google link is available on https://www.iiits.ac.in/admissions/b-tech-programme/josaa-csab/
- 3. The documents uploaded by the candidates will be **verified by the Institute**, also the admission confirmation letter from IIIT Sri City will be issued between 20th August, 2025 and 23rd August, 2025.

The SC/ST/OBC-NCL candidates of Maharashtra State have to produce their caste validity certificate in the format available on JoSAA/CSAB 2025 website.
- (ii)ST certificates from Tamil Nadu state must be issued by the concerned Revenue Divisional Officer
