Approval of BoG for the addl length of perimeter wall constructed.

Final contract value with 18% GST on revised contract value is - Rs 32144144/-

This item is approved by the Board

Item No. BoG16/AP2

Approval for Financial closure of the NJRC project of BH-3&4 with Dining Hall.

The contractor for the BH 3 & BH 4, with Dining Hall is M/s NJR Constructions (P)Ltd., has completed the project and handed over to IIITS on 25/12/2023. The project was inspected by all parties and snags list was handed over to the contractor M/s NJRC on $31/12\ 2023$. The contractor submitted their final bill (RA 17) on 29/12/2023.

After due study, M/s CUBE vide their letter dated 7^{th} November 2024 has recommended to levy a delay compensation amount of Rs.1,32,603/ - which is 3.5 % on the value of the balance work done by the contractor after the EOT No. 6 i.e. after October 15 2023 and to release the balance withheld amount to the contractor M/s NJRC. A legal opinion has also been obtained wherein he opined as under:

"in my opinion, the last EoT may also be declared as without penalty, or with token amount as penalty keeping balance amount of work in view, without any obligation to either party for any associated expenditure involved, if any."

Hence, it is recommended to release the balance amount out of the 10% of withheld after deducting the delay compensation amount of Rs.1,32,603/- as recommended by M/s PMC CUBE to the contractor M/s NJRC.

Item No. BoG16/AP3

Approval of Board for closure of the CUBE contract, on completion of DLP of NJRC Project.

M/s CUBE has been providing Project Management Consultancy Services to the IIIT Sri City, for ongoing projects, of construction of 3 & 2 bedded hostel blocks with a dining hall, to be constructed by the M/s NJR Constructions. Due to extension of the NJRC contract, the CUBE tenure also got extended and the contract value has been revised to Rs 65, 88,120/- plus 18% GST, based on deployed manpower (BWC 19/AP2 dt 26 Dec 2023).

As per the contract conditions, CUBE is eligible for taking payment of 90% of Rs. 77,73,982/-upon financial closure of the contractors claims / bills and the balance 10% to be paid after the expiry of 1 year DLP i.e. after 25^{th} December 2024.

Further, as the NJRC had handed over the project on 25 Dec 2023, it took one month for them to list out the snags and during the period, M/s CUBE had deployed one Manager and the cost is working out Rs 1, 17, 645/- as they deployed one person only. It is recommended to pay this addl amount to M/s CUBE. With this, the contract with M/s CUBE will come to the closure by 26 Dec 2024.
