- 2. Bidders are advised to visit the website frequently to find any addendum/ Corrigendum issued or extension of due date for submission, etc. No separate intimation will be issued /advertised in this regard.
- 3. The tender in single bid systems in sealed envelopes shall be submitted in the office of Registrar in the prescribed format before the due date and time as mentioned in NIQ. No other mode of submission is acceptable.

4. Sealing and Marking of Bids:

Sealed quotations in single cover consisting of Technical bid and Price bid super scribing the NIQ No., Name of the work, Contractor name & address will be received at this office up to 16:00 hours on or before 23/09/2025 addressed to the Dean Infra & Planning, IIIT Sri City, Chittoor, 630, Gnan Marg, Sri City, Tirupati District, AP, PIN:517 646. Technical bid will be opened at 16.10Hrs on the same date and further information, if any, may be obtained from the office.

- 5. Offer must be legible, clear and free from overwriting and cutting. Incomplete submissions are liable to be rejected.
- 6. Site Visit: Before tendering, every bidder is advised to inspect the site/locations of work and its environments between Monday to Saturday from 10:00 Hrs to 16:00 Hrs. except Sunday and Govt. holidays, to ascertain the exact requirement of the NIQ, at his own cost.
- 7. Completion period: All the specified works shall be completed within 30 days of award of work including sample approval if any

8. IIIT Sri City reserves the right:

- a. To accept or reject any or all quotations either in whole or in part or to invite revised price bids or to annul the bidding process
- b. To postpone and/or extend the date of receipt/opening of quotation or to withdraw the same at any time before finalization without incurring any liability to the affected Tenderer / Bidder.
- c. To omit/delete any item(s) of work from the schedule at the time of allotment or before the commencement of work or during the execution of work without assigning any reason whatsoever.
- d. To change the quantity or add the item or cancel the item/service required.

- 9. If the date of opening of the bid is declared as holiday, it will be opened on the next working day at the same time.
- 10. **Bid Evaluation:** The bid should be submitted strictly in the prescribed 'Annexure A' and should remain valid for a minimum of THREE (3) months.
 - a. The bidder should have experience of having successfully executed/completed similar works in any one of the organizations like University, Government Organizations and reputed companies during last 3 financial years ending 31st March2025. Without required experience, at least in one of the organizations, the bid will not be considered
 - b. Similar works means those works of civil works, building works, floor finishing works, wood works, structural steel works, Liquid Petroleum Gas Pipe line work etc.
 - c. Documentary evidences for work experience, turnover, GST, PAN all as indicated & required in the tender document should be furnished without which it will not be taken into account.
 - d. Financial bids, which are incomplete and are not submitted in the prescribed format, will be summarily rejected.
 - e. The Financial bid should clearly contain the details (without erasers/overwriting etc.) as mentioned in the form.
- 11. The works shall be carried out in designated areas of the IIIT Sri City campus as per the directions of Engineering In-charge.
- 12. Works shall be awarded to L1 tenderer on L1 quoted rates. Price quoted by tenderer shall be fixed and not subject to any escalation whatsoever during the period of execution of the contract including the extended period, if any.
- 13. This tender notice shall be deemed to form an integral part of the contract to be entered into for this work.
- 14. The successful bidder needs to arrange all safety materials to the locations at his own cost as per the scope of the work.
- 15. The successful bidder has to ensure the safety of the manpower/vehicles deployed in the premises. IIIT Sri City will not be responsible for any incident arising during execution of the work.
- 16. Accommodation and Transportation should be arranged by contractor themselves.




17. PAYMENT TERMS:

- a. 95% of Bill Value for the works shall be made after completion of the entire work and within 30 days from the date of certification by IIITS and balance 5% will be released after 6 months of completion of work.
- b. Payment will be initiated only on submission of bill with due certification by the concerned authority of IIIT Sri City
- 18. TAXES AND DUTIES: The Rates unless otherwise specified, will be deemed to exclude sales tax or any other taxes and duties, which are in force or may be levied by the Central/State/Local Governments from time to time, on the production and sale of the goods.
- 19. **JURISDICTION:** All the disputes arising out of this order shall have exclusive jurisdiction of Tirupati, Andhra Pradesh only.

20. SCOPE OF WORK:

- 1) Supply, testing, and commissioning of the gas pipeline from the gas storage room to the ground floor and first floor kitchens, including all necessary connections and fittings as directed by the engineering in charge. The shop drawings and the sample materials should be submitted to the Engineering Unit within 7 days of receipt of order for approval, before proceeding with the work.
- 2) Supplying, Fabricating and Fixing of the weld meshes with mosquito net with necessary support structure in Mild Steel in the open corridor area of Dining Block-2, as indicated in the attached image and instructed by the engineering in-charge. Please ensure that the sample is submitted to the engineering unit once it has been reviewed and approved before proceeding with the work. Ground Floor and First Floor plans of Dining Block 2 are attached for reference in page No: 10 &11.





3) Rubber flooring to be laid in the music room located in the academic block basement. Please ensure that the sample is submitted to the engineering unit once it has been reviewed and approved before proceeding with the work.
